Agenda No. 2 Report on AHC FFA Field Day

- Amy Rice shared a recap of the FFA Field Day that was hosted at Allan Hancock College. This event was part of the agriculture program and the outreach to high schools to showcase the agriculture-related pathways offered at AHC, including veterinary technology.
- An overview of the Veterinary Science contest was presented. It was a state qualifying competition which drew students from 10 high schools across California and brought 13 teams to the veterinary science competition. The contest included four activities: veterinary tool identification, breed and parasite identification, a general knowledge test and 3 practicum rooms with the contestants demonstrating hands-on skills.
- AHC Veterinary Technology faculty Amy Rice, Jesslyn Tilley and Julie Yuhas assisted with preparations and judging of the contest. Student volunteers also helped with all aspects of the event.
- This was a great opportunity to expose high school students to the AHC Veterinary Technology program specifically and veterinary medicine in general.

Agenda No. 4 Vet Tech Office & Storage Space

- The ongoing challenge that the program continues to face is the lack of dedicated instructional and storage space. No dedicated classroom space exists for the veterinary technology program, and storage space currently exists in two closets in Building W, and a cupboard in the physics lab hallway. This necessitates set-up and break-down of any training materials/training manikins and moving them across campus, often from ground level storage to second floor classrooms before and after each each night class.
- The original hope was that the space in W-24 could be used for vet tech instruction, but it turned out that this room is not allowed to be used for instructional space at this time.

Discussion:

- Linda Metaxas mentioned the prior plan to use the previous MESA center room in Building W, which might become available once the covid testing site is no longer housed in that room, however Amy Rice shared that she was informed that this is currently being used for the nursing program.
- Linda Metaxas spoke to the history of the program, stating it was a big priority to find space for this program and that a plan was in place for instructional space at one time, but that priority disappeared as people retired or personnel changed within the college administration. She stated that she feels "we are starting from scratch" in relation to this challenge and that we need to keep informing administration of the program's needs. Amy Rice stated that the needs will be addressed in the Program Review done each year.

Agenda No. 5 2023-2024 Enrollment and Program numbers

• Amy Rice shared that 22 students were accepted into the 2023-2024 program, with one additional student returning in the spring semester to finish one class for her certificate. She also shared that 17 students in the current cohort will complete the program this month.

She also asked if the program courses were currently being taught in person or on-line. Amy Rice stated all courses other than VT 302 were in person classes.

Discussion:

• Linda Metaxas asked if DE instruction was a possibility in the future that might help the strain on students that are working full time, taking all of the program courses at night and commuting to the college. Amy Rice shared that many veterinary technology programs do offer online instruction and coursework, but that program would likely need to break into an in-person veterinary assisting





curriculum and DE curriculum aimed at those students with full time veterinary hospital jobs, planning to take the VTNE. Jesslyn and Amy both discussed their challenges trying to instruct to a class in which the experience level varies from little to no experience handling animals, to many years of in hospital veterinary and animal husbandry experience.

• Amy Rice shared that some veterinary technology programs provide vaccination clinics to employees of the college that allow their students to practice basic skills. Kerri and Dr. Marrie offered to work with Amy to determine ways in which Santa Barbara Humane can help AHC Veterinary Technology program students can get the hands-on experience they need. Jesslyn Tilley will be a contact at the County of Santa Barbara to help facilitate work experience opportunites at their facility also.
