Counseling proposal:

Most community colleges have an alternate route for meeting competency in Math by accepting SAT, ACT, CLEP, AP or other test scores as well as using high school math courses. In addition, the college in the past has used a passing score on a local/homegrown Math proficiency test developed by the Mathematical Sciences Department. We propose the following:

Students will demonstrate competence in mathematics by meeting any one of the following standards:

- A. Pass one of the following courses with a C or better: Math 309, Math 321, Math 331, Math 333/334 or any 100-level math course of at least three units.
- B. Successful completion of Algebra 2 or MATH 3 (UC A-G course list) at a high school with a grade of 'C' or better.
- C. Successful completion of Algebra 2 or higher at an accredited collegiate institution.
- D. Minimum score on ACT of ____ or SAT of ____ or CLEP of ___ or score of 3 on AP Statistics or any of the AP Calculus exams.
- E. Pass the AHC Mathematics Proficiency Test.
