- Shared experiences with submitting a program proposal for South Central Coast Consortium review and recommendation.
- Revisited current conversations regarding the upcoming fall 2027 implementation of the Standardized Attendance Accounting Method (SAAM). SAAM is basing apportionment and FTES on itemized unit-hours calculations (lecture, activity, and laboratory). With the anticipated implementation date, current aggregation of units and hours of AHC courses are underway. The courses that have dangling hours or not meeting the 0.5 unit threshold will be brought to the respective departments and faculty for recalculation of units and hours.

 modification form. The curriculum team can ensure that the CEEM request is attached to the course
 outline of record. There is no need for a course proposal if the CEM change did not warrant curricular
 changes.
