5.a. Minutes of the November 25, 2025, Meeting

6. Information Items

- 6.a. Financial Report for Auxiliary Programs

Jennifer Schwartz reported that PCPA currently reflects an excess of revenue, largely due to a highly successful holiday production that exceeded prior records. She noted *Shane* is currently under its ticket sales goal and may close below projections. She indicated some ticket revenue goals were set higher than actual and adjustments will be made in future projections.

Ms. Schwartz reported that Nicole Raftery's final day as Director of Marketing is February 27, 2026 and noted she will be the interim marketing director.

Ms. Schwartz stated PCPA anticipates a significant deficit this fiscal year due to a smaller transfer than originally projected and will utilize reserve funds accordingly.

Keli Seyfert noted 27 student clubs have been chartered this academic year, including new and rechartered clubs.

Dennis Curran reported on a \$70,000 inter-fund transfer from Follett Trust revenue to the Associated Student Body Government (ASBG) Trust, consistent with prior board action increasing support to ASBG from \$50,000 to \$70,000 annually.

- 6.b. Audit Report for the Pacific Conservatory Performing Arts (PCPA), Fiscal Year 2025

Jennifer Schwartz reported PCPA received a clean audit with no findings. The prior fiscal year reflected an approximate \$20,000 deficit at year end.

- 6.c. Auxiliary Programs Corporation Meeting Prep

Dennis Curran reported that Chelsea Humes will manage future agendas and meeting minutes.

7. Oral Reports

PCPA

Mark Booher reported the spring season includes three concurrent productions. *Shane* is currently running, while *Come From Away* will enter rehearsal March 10 and will conclude the spring season in Santa Maria before the summer season opens with *Luchadora!*

Mr. Booher noted strong artistic performance of *Shane*, though ticket sales are below projections.

PCPA is actively recruiting for conservatory programs, summer season staffing, and internships. Staff will attend the Theatre Resources Group leadership summit in Colorado Springs, the Southeastern Theatre Conference for recruitment, and the United States Institute for Theatre Technology (USITT) national conference in Long Beach.

Planning for Season 63 is underway, including licensing negotiations and production feasibility analysis.

Athletics

Kim Ensing reported men's basketball is advancing in the state tournament and will compete at Citrus College. Baseball is ranked 16th in the state. Planning continues for the Final Fore Golf Tournament, with sponsorship levels on track.

ASBG

Ora Shrecengost reported a successful Black History Month event attended by approximately 250 students. Upcoming events include Diversity Day, the Asian Pacific celebration, and the year-end club banquet.

Student representatives will attend the Student Senate for California Community Colleges General Assembly and a Washington, D.C. advocacy trip.
