4. Information Items

4.a. Financial Report for Auxiliary Programs

Keli Seyfert provided a brief review of the financial report. She shared ASBG chartered 20 clubs and had a major event. Revenues from Follett commissions have been posted and the expenditures have been very low due to lower activity. She also noted, over \$19,000 dollars in lost revenue was captured from HEERF funds. Ms. Seyfert highlighted funding that went from ASB and Follett commissions to the AHC Foundation Hancock Promise Scholarship Program.

Jennifer Schwartz reviewed PCPA's financial report, noting there was a slight surplus. She also shared PCPA received forgiveness on the PPE loans.

4.b. PCPA Volunteer Recognition

Dr. Walthers recognized the PCPA volunteers listed.

4.c. Oral Reports

ATHLETICS

Kim Ensing announced the first home football game will be this Saturday, pending the outcome of the Covid tests. Men's and Women's soccer will also play this week. She noted the athletics fund balance will start seeing activity this year. Ms. Ensing reported all football tickets are going to be processed electronically and thanked Keli Seyfert and Shelby Scott for their work on that process, which will help with handling less cash.

Dr. Walthers shared with the student representatives that students receive free entry to sporting events.

ASBG

Mirian Solano shared upcoming ASBG events such as Bow-WOW and Constitution Day. She said the new student body officers have been sworn in.

PCPA

Jennifer Schwartz shared show and ticket sales information for *Lady Day* in Solvang. Attendance has been less due to the attributing factors of Covid and increasing tourism costs in Solvang and Buellton.

Ms. Schwartz shared the students have returned and staff are excited to have the students back. She said sales goals will be lower due to the uncertainty of the impact due to Covid and there will be fewer shows due to the Solvang Theaterfest construction. She reviewed upcoming plays and the Interplay series targeted to Zoom audiences.

Ms. Schwartz discussed grant and financial opportunities and the need for a redesign of the website. She noted Equity, Diversity and Inclusion training was introduced to the students and reviewed staffing changes and hiring needs.

Dr. Walthers asked about in-person theatre protocols to attend shows. Ms. Schwartz said they are working with Associate Superintendent Smith and Human Resources Director, Ruben Ramirez for information. Dr. Walthers noted other event venues are requiring masks, proof of vaccination, or a negative test. Further discussion will be held to determine which protocols will need to be followed to attend PCPA shows and indoor athletic events.
