- Get Tax Return Transcript by Mail - Go to www.irs.gov, under the heading "Get Your Tax Record". Click "Get Transcript by MAIL." Make sure to request the "IRS Tax Return Transcript" and **NOT** the "IRS Tax Account Transcript."
- If you and your spouse filed separate 2023 IRS Income Tax returns, signed copies of your **2023 IRS Federal Tax Return(s)** OR **2023 IRS Tax Return Transcript(s)** must be provided for both you and your spouse.
- Get Tax Return Transcript Online - Go to www.irs.gov, under the heading "Get Your Tax Record". Click "Get Transcript online." Make sure to request the "IRS Tax Return Transcript" and **NOT** the "IRS Tax Account Transcript."
- Automated Telephone Request – 1-800-908-9946
- Paper Request Form – If requesting a transcript by paper form, use IRS Form 4506T- EZ or IRS Tax Form 4506-T. Both can be found on www.irs.gov.
