The program currently meets IGETC and CSUGE requirements for students looking to transfer. Underlining skills such as critical thinking and collaborative learning are curriculum standards. The program created an ADT for Geography and has added courses to help guide students onto a career path. ADT for Geography courses such as Weather and Climate have been implemented and more new courses are in the planning phases for 2022. The program's weather station has been implemented into the curriculum of multiple Geography courses and continues to allow students to benefit from experiential learning. GIS courses are also part of the ADT for Geography plan.

The program has a lab course for Physical Geography on the Fall 2021 schedule and continues to build toward rolling out all of the courses within the ADT for Geography plan.
