1. Has your program mission or primary function changed in the last year?

No.

2. Were there any noteworthy changes to the program over the past year? (eg, new courses, degrees, certificates, articulation agreements)

ANTH 107 – Indigenous People of California was developed recently but unfortunately, it was not approved for the CSU Area F/Ethnic Studies requirement. This course has not been offered yet and will likely not be offered unless it meets the CSU Area F requirement.

The number of degrees awarded dropped from 6 in 2020-21 to 1 in 2021-22 academic years.

Enrollment/Headcount showed an improvement from 2020-21 to 2021-23 academic years by roughly 20% and FTES also improved from 67.8 to 78.8.

Enrollment by modality shows the 21% of the students took onsite classes while 79% enrolled in in traditional DE classes.

The overall success & retention of students taking Anthropology class dropped 76% in 2020-21 to 69% in 2021-22 academic years.

Learning Outcomes Assessment

a. Please summarize key results from this year's assessment.

This year's Learning Outcomes Assessment has not been completed as the spring semester has not ended yet. Based on the data it appears the "Actual Result (Score) for the program PLOS was in the low to mid 60th percentile which is slightly below the target of 70%.

b. Please summarize your reflections, analysis, and interpretation of the learning outcome assessment and data.

The sample size for the classes has been low due to changes in enrollment patterns. The traditional face-2-face classes have roughly half the enrollment of pre-pandemic sections and the attrition in DE classes has been much higher as well.

c. Please summarize recommendations and/or accolades that were made within the program/department.

In order to attract students a hybrid 8-week section of ANTH 102 was offered in the spring 2023 semester. The CEM of 40 was reached but by the end of the semester the enrollment is down to 20. This is an improvement over the poor enrollment and high attrition for this face-2-face course in fall. Depending on enrollment trends, the program will likely continue to offer late start hybrid classes for ANTH 101 and 102.

- 1. What data were analyzed and what were the main conclusions?

Class schedules, Heatmap Course and Enrollment & Headcount data were analyzed.

The majority of students who enrolled in Anthropology classes took them as DE (79%). Pre-pandemic evidence shows that onsite enrollment was about 40% enrollment and DE was roughly 60%. The goal is to increase enrollment in traditional/face-2-face sections.

2. Based on the data analysis and looking through a lens of equity, what do you perceive as *challenges* with student success or access in your area of focus?

The challenges for students in the Anthropology program include:

- favoritism of DE classes
- lack of engagement
- poor time management
- poor critical thinking skills
- failure to follow instructions

3. What are your plans for change or *innovation*?

Based on the success of an 8-week hybrid class offered in the spring of 2023, I plan to offer more late start hybrid classes. The reasoning is that many students prefer shorter classes and the combination of traditional face-2-face and DE modalities will hopefully attract students to take these classes. The current plan is to alternate between ANTH 101 & ANTH 102 courses each semester.

I have also changed the Term 1 8-week DE ANTH 101 class to a 17-week DE section. This means that that there are now two 17-week DE section of ANTH 101. The reasoning for this change is that enrollment was typically low for Term 1 & 3 sections and student success was also low. This knowledge is based off personal experience as the evidence cannot be disaggregated from the data available on the Program Review website.
