9. President's Remarks [15] (Allegre)

10. *LOAC Assessment Brochure Update [10] (West, Butler)

L. West introduced Steven Butler, the new analyst for LOAC. The brochure was updated, and items were added that include a checklist and tips on how to streamline assessments. They changed the language to let faculty know that there is PD available each semester.

11. Course Enrollment Maximums [15]

This group met with Senate Exec recently and discussed the different groups that have given input to the task force. The goal was to establish course maximums based on pedagogy– what are the best learning guidelines for students to succeed. The course maximums should not be determined by the facilities cap, how big the room is. The task force is continuing to work on this, and it will be going to department chairs for input. The members looked at what other schools have done and have made progress with this project.

The BP/AP 7310 Favoritism is still being revised. The current BP was adopted by the Board of Trustees last November. The AP was proposed by the District. Previously Senate and the district agreed that we do not need an AP. Subsequently, Trustee Hall stated that he wanted an AP, which was drafted by the HR Council. This draft AP repeats policy language but with greater restriction than in the BP and includes much of the language Senate objected to in the past. Because of this Senate Exec rejected this draft language and suggested that we refer back to the League templates for Nepotism to provide language for the AP. The language is broad enough to cover all employees and aligns with government code. This item is going back to the HR Council for review.
