5. President's Remarks. [5] (AR)

A. Restrepo read a statement from President Walthers that was emailed to Academic Senate Exec (ASE) members titled "Working Together" regarding optimism in working with faculty and acknowledging that the work being done has changed the odds for students. In the email, K. Walthers listed many accomplishments over several years. He admitted that he is interested in changing the campus climate and looks forward to completing the essential business necessary for accreditation. Jon Hooten has been asked to step forward as co-chair for Standard IV. A. Restrepo referenced a meeting ASE had with Kevin last week and acknowledged the extent of distressed relationships with the district. He shared that many meetings resulted in individuals feeling that they were being talked at rather than actual communication. Restrepo believes we have begun to move in the right direction and reminded faculty that you are supporting shared governance by becoming a member of the Senate. He shared that ASE is guided by 1) what is best for the faculty and students 2) what is consistent with our role as members of the Senate Executive Committee. Restrepo thanked Kevin for that communication.

10. Distance Education (DE) Modalities Senate Resolution *[20] (All)

In developing this resolution, feedback from instructional and service faculty was integrated into the document. This document is necessary for the Faculty Association to negotiate with the district to offer a range of DE modalities in future semesters. NOTE: Correct AACCC to ASCCC. Language included stated that Senate will develop a list of definitions for each of these instructional modalities and how they are implemented. Also, a statement requiring that AS reach a mutual agreement on the language that would appear in the Class Schedule so that students can clearly understand which modality they are enrolling in. L. Campos suggested that we add definitions in the draft specific to service faculty.

- This policy has been changed from faculty Hiring to a general Recruitment and Hiring policy, developed by HR Council, reviewed and edited by ASE

Cl. Diaz asked for clarification around the distance interviews on the first round of interviews and if the committee makes this choice. R. Ramirez responded we are trying to be inclusive and cast a wide net. He stated that 10-14 candidates are typically invited to participate in first-round interviews. AHC does not have the resources to reimburse all participants for travel. When there is a remote interview for the subject matter expertise, you can narrow the group to a smaller, more qualified group for their teaching demonstrations. J. Scarff asked if there is any liability if we do not offer all groups the same style of interview. R. Ramirez stated that there are distinctions between an accommodation versus offering a remote interview process offered to all within that group.
