10. BP/AP 3420 Equal Employment Opportunity and Staff Diversity * [10] (T.

Roepke/R. Ramirez)

T. Roepke shared that this is a revision necessary because of recently revised language now includes the new BP/AP 7120 and recent legislative changes.

11. BP/AP 4105 Distance Education * [20] (F. Patrick)

This policy has implications for accreditation. There are no changes to the BP. The AP has recommended changes from the league and has changed based on Title 5. An addition of a statement on page 3 guides faculty to monitor and ensure regular and substantive contact. Another addition is the paragraph requiring that faculty are certified before teaching online courses. L. Manalo asked for clarity around the "peer review" process. The DE committee developed language for a peer review process and is looking to standardize the process to ensure and monitor effective contact in online courses. That peer review process will come to Senate for approval. L. Manalo asked how we could approve this BP/AP before clarifying the Peer Review process. The recommendation is to focus on Section B of the OEI Rubric. A. Fox asked if the certification process would change as we offer different modalities. F. Patrick said that the certification process would be a Senate decision. J. Scarffe asked about consistency in the language of substantive versus effective. F. Patrick responded that substantive is a legacy term. T. Nuñez from the English department stated that some faculty voluntarily participate in the peer-review process. The peerreview process and the DE certification process needs to be approved by Senate. Because the implications included in the AP involve FA, H. Elliot suggested we wait on approving the AP. Please share this with departments and let them know that ASE will meet with FA and R. Curry to clarify the peer review and certification processes.

12. AB 705 Equitable Placement and Completion Improvement Plan * [25] (Senators and Department Chairs from Math & English Depts/B. Curry/P. Murphy)

This item is before the Senate because the Senate president must sign this document based on approval from Senate members. He asked the English and Math faculty to share their perspective on the options and

rationale for those decisions. R. Curry introduced E. Biely from IE, who also was part of this process. P. Murphy started by contextualizing AB 705 timeline. Colleges are no longer allowed to place students in courses based on tests, only HS coursework. The AB 705 task force reviewed data that indicated a disproportionate impact and discovered that we are out of compliance with AB 705 in terms of throughput. Decisions made in this document were based on input from both English and Math department faculty and are interested in this being on the Senate agenda to get broader awareness. The Chancellor's office recommendations include providing support services for success in transfer-level courses. D. DeGroot pointed out this may affect prerequisites and advisories listed in course outlines. L. Campos wanted clarity about the Math department's decision not to support Option #3 to keep the lower-level algebra courses. L. West shared that with appropriate support, students can be successful, which may impact their decision to transfer. K. Runkle stated that many students are not interested in transferring to universities, and the decision made does not serve those students. Please share this with your department to see if you have any feedback.

- Update (T. Passage, B. Stokes, NJW, ASE) T. Passage shared that the members of Standard II are "chugging along." He feels confident that they can get a draft completed by the end of the week. N. Ward shared that Standard III will also share the drafts. J. Scarffe shared that the drafts are near complete in Standard I. P. Murphy shared that on March 31st, there will be an accreditation information session about the standards, participants, and opportunities to provide feedback.
