Kevin Walthers: K. Walthers shared the Accreditation timetable –ISER draft 9/22, Senate Review 10/22, BOT Approval 11/22, ACCJC Submission 12/22, Formative Team Visit 3/23. Shared Governance Orientation. [60] (AR/Senate Exec)

- <u>What is Shared Governance</u>?
 - $\circ~$ structures and processes with an emphasis on effective participation, with a long history in higher education
 - o requires a culture of shared governance

- o not a legal term, but codified in California AB1725, CA Ed Code, and CA Title 5 Regs
- <u>Two types of shared governance</u>
 - *Effective Participation* all opinions are heard [staff, faculty, students, administration] at Hancock, through the CCPD
 - Primary Responsibility of Academic Senate in Curriculum and Academic Standards ["10+1"]
 the Senate is a co-leader, with the administration, in the CCPD structure
- Role of Senate in "Academic and Professional Matters" [10+1]
 - Title 5 carves out exceptional circumstances and compelling reasons, but otherwise, Board must rely primarily on the Senate
 - If an agreement is not reached, the status quo remains
 - Most are not contentious, but a few are [e.g., scheduling of classes] should it require consultation? The state academic senate has determined it is an "academic and professional matter."
- Role of the Senate in the CCPD
 - Councils are shared governance with reps from all constituencies
 - Seven specific councils plus College Council
- <u>Academic Senate and Faculty Association</u>
 - Senate's focus is on academic and professional matters
 - FA's focus is on working conditions
 - Overlap means FA should consult with Senate on evaluations and service areas important to have good relationships
- The Brown Act & Robert's Rules of Order
 - Brown Act must be followed open meetings for all governing bodies of public agencies/bodies
 - Includes requirements for "teleconference" meetings that may present problems in the Zoom era
 - State executive orders during the pandemic suspended some of these requirements, extended by AB361, allowing virtual meetings in cases of declared emergencies
 - The decision to meet remotely is not up to us
 - Not required to follow RRO
 - Hancock uses
 - 1st & 2nd readings
 - Consent agenda as a standing item
 - Information Items/Reports
 - Simple majority for most items
