10. Technology Masterplan. * (10) (AR/FP/A. Specht)

Department feedback on the technology master plan:

- Change made to the "integration" goal to "integrate shared governance practices in the technology governance structure and planning processes" with a goal of constant communication to avoid surprises and to include faculty voices in technology discussions.
- o Added "staff" to be included under the goal of "preparation" [professional development.]
- o A proposed change to divide the "integration" goal into two: "governance" and "integration," with the first sentence in the former and the second sentence in the latter
- Proposed change of "Instruction" to "Implementation" [goal #6] and add a reference to "relevance" [as well as currency] and change "classroom technology" to "instructional technology."

11. BP/AP 4020 Program, Curriculum, and Course Development. * [5] (J. Raybould-Rodgers)

J. Raybold-Rodgers shared that this BP/AP has been reviewed by Student Learning Council and AP&P. Basic changes include language from Title 5 regarding hours per unit. R. Curry explained the differences in converting hours to units. Please share this with your departments for feedback.

REPORTS AND DISCUSSIONS (NON-ACTION ITEMS)

12. Conversation With the Superintendent/President. [20] (K. Walthers/All)

A discussion on collegial consultation, effective participation in decision-making, and campus climate.

- N. Ward requested a <u>memo to faculty</u> when new faculty are hired Walthers replied that they could do a better job communicating and that will aim to send message to all employees
- D. DeGroot asked about <u>common course numbering</u> Walthers replied that for most folks, it seems simple, but it is, in fact, not easy – better, though, if we do it ourselves rather than being forced upon us quickly by legislation
- o H. Elliot asked how the past two years have impacted his leadership Walthers replied that he had been inspired by how people stepped up and now needs to figure out how not to be in crisis mode. There could be an opportunity to offer a 4-year degree here; he wants a conversation about doing big things going forward.
- J. Jozwiak asked how he sees us <u>serving the community going forward</u>, especially with ESL and community education – Walthers replied that while we are still providing essential programs, there's room for more, such as: establishing the trucking program,

getting out to Guadelupe, Buellton, and Lompoc. He is in regular conversations with R. Curry and S. Ramirez Gelpi; G. Siwabessy is working on transportation between Lompoc and SM.

- M. Segura asked about <u>PT faculty teaching 85% instead of 66% load</u> Walthers replied that he thinks it's a good idea because it meets needs in rural areas [big urban campuses oppose it] – Newsom vetoed it this week
- A. Restrepo asked whether it's optimistic to consider us out of crisis mode and <u>how we</u> will rebuild enrollment Walthers replied that concurrent enrollment helps. Still, we need to serve our adult learners better, grow Lompoc enrollment, and develop minicourses.
- H. Elliot asked <u>what his impression was of the campus climate survey</u>. Whether it has influenced his approach – Walters replied that the survey showed improvement, that people are energetic to see each other again. We can learn through discussions in focus groups.

13. Discussion on Scheduling of Classes. ** [15] (ASE/All)

The role of the Senate in developing procedures and the role of discipline faculty in determining which courses are offered.

- Concern from faculty about their role and lack of consistency across departments
 [particular concern from service faculty on the scheduling of their service hours]
- Scheduling of classes is related to program review, assessment, guided pathways, etc.,
 that are faculty-driven, so why isn't scheduling considered a "10+1" issue?
- State Academic Senate Resolution [No. 17.01] from 2017 urging local senates to assert their purview in scheduling classes
- o Discussion with K. Walthers, R. Curry, and G. Siwabessy recently seems to show a desire to find common ground
- Faculty efforts regarding modalities are moot if faculty are not involved in scheduling decisions

14. Accreditation Update. [10] (ASE)

N. Ward shared where faculty can review the current draft of the standards and the ISER. Restrepo urged faculty to read this document as it will affect faculty.

15. CCPD Councils and Committees' Reports. [3 min. each unless otherwise indicated.]

• Institutional Effectiveness. (L. Lee)

Institutional Effectiveness is currently focusing on Accreditation. They are proofing the document, putting the final touches on it, and summarizing the reports for the college council. Looking forward, we are beginning to talk about the Spring planning retreat and the evaluation of the new program review process when it is implemented.

• Technology Council. (AR)

Focus has been on the BP/AP policy reviewed today and the goals of the Technology Master Plan.

• Human Resources. (TR)

HR Council is working on BP/APs that will come to Senate soon.

College Council. (AR)

Council meets in person on Monday afternoons. They will look at the Campus Climate Survey and the Student Equity Plan at the next meeting.
